Due to the nature of the programs, NO REFUNDS OR TRANSFERS ARE AVAILABLE FOR TRAVEL TRIPS, including but not limited to the Backpacking Trip and West Virginia Adventure Trip.

2024 Tuition Refund Policy

Some or all of camper tuition can be transferred to another camper or to a different week of camp within the same summer. It may also be given as a donation to the camp to help other children attend summer camp. A refund may be considered after refund application has been submitted by the guest. Approval of the refund is at the discretion of camp management. Refund applications for summer camp must be submitted at least two weeks PRIOR to event start date. Refunds will only be considered when refund application is completed in full and on time.

A portion of your tuition will be retained as a processing fee according to the following scale:

Camp sessions costing less than \$100 ...\$15 is non-refundable Camp session costing \$100-199\$30 is non-refundable Camp session costing \$200-350\$60 is non-refundable Camp session costing over \$350\$100 is non-refundable

To reserve your camper's spot at a camp session, a 50% tuition deposit is required. Church scholarships do NOT apply towards the 50% deposit.

For example, consider a session costing \$320 where a camper is receiving a 50% church scholarship. The scholarship is applied through the church scholarship code, reducing the parent portion down to \$160.

The parent must then pay the remaining \$160 at the time of registration

(which is 50% of the original tuition amount) in order to secure the camper's spot.

Registrations Received May 15th or After - Full Tuition is due at the time of registration to secure your spot.
